



In the field of life sciences, the EPO has imposed a number of additional limitations on patentability of inventions such as new medical uses of known compounds, stem cell technology inventions, gene sequence inventions, new dosage regimens, diagnostic and surgical methods, plant and animal breeding methods and bred plants and animals.

In the development of inventions either for pharmaceutical, food, feed or other applications, the scope of the claims is of major importance for the value of the patent and at the same time an issue of debate within the national patent offices. It is important to draft patent applications which contain the necessary basis to ensure appropriate protection.

In biotechnology, the claim scope which is found allowable by the EPO based on a model system is often a critical issue and the commercial product is often not yet fully envisaged at the time the invention is made. In order to optimize the scope of patent protection, it is necessary to consider all aspects of the invention and carefully consider the patent drafting strategy in view of the availability of data.

The high level of expertise De Clercq & Partners offers in the field ensures that these issues are taken into account the first moment that the invention is considered in order to properly draft priority documents.




